## CONSENT OF MEMBER TO EXEMPTION FROM AUDIT - ORILLIA CURLING CLUB

As you may be aware, the Orillia Curling Club is a "corporation without share capital" or, as known more commonly, a not-for-profit. Because of this status, it is currently governed by the Corporations Act of Ontario and, amongst other things, is obligated to have an audit each fiscal year. The purpose of this audit is to provide some level of comfort to Members that the financial management of the Club has been examined by independent auditors and found to be sound. However, this requirement can be done away with so long as all members of the Club consent. The Board of Directors has considered this requirement and, given the Club's financial statements are relatively simple (approximately 90% of the funds we collect from Members are paid directly to the City of Orillia as rent), the Board believes that an audit is not required. As well, the added expense of an audit would result in an increase in the Club's costs which would have to be passed on to members by increasing membership fees. Deciding to forgo an audit does not mean that the Club is not accountable. The Club will continue to use reputable accountants to produce financial statements and file tax returns in accordance all applicable laws.

As a result, the board is requesting all Members provide the consent required to exempt the Club from this audit provision.

**By signing the bottom of the Registration Form, you, as a member of the Orillia Curling Club (the "Club"), consent to the exemption of the Club from the audit provisions set out in the Corporations Act of Ontario in respect of the next ensuing fiscal year of the Club.** Should you have any questions about the audit requirement, this consent or how the Clubs is committed to accountability, please do not hesitate to contact the President.
